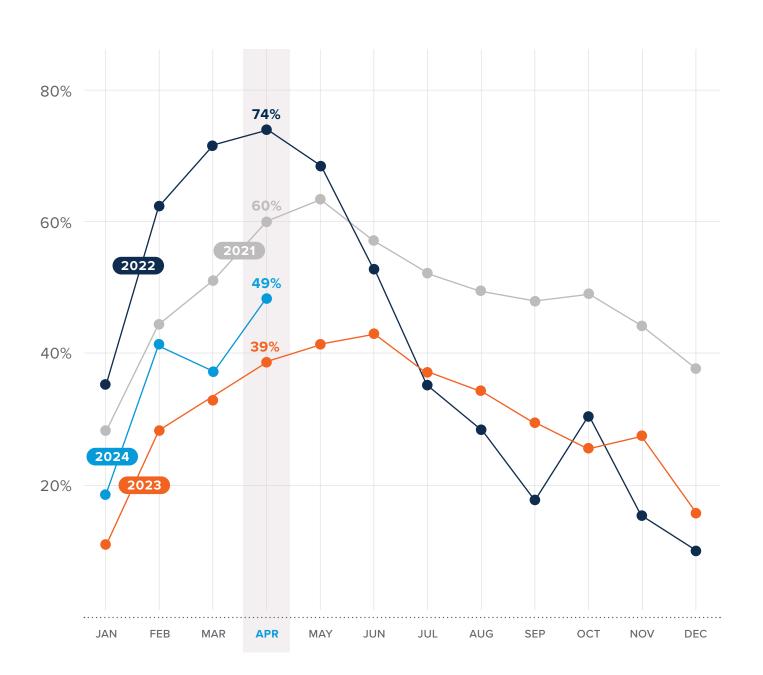




Median Closed Sales Price For Current Month Sold Properties





Monthly Payments Compared to Income Trendline King County








Percentage of Pending Sales that do not Close
